Describe the present and original (if known) physical appearance

All the buildings in this nomination are related to the first banking efforts in Ellis County and as such were instrumental in the development of the area both commercially and agriculturally. Ellis county is predominantly arid, flat and dry. The most readily grown crop is wheat and most of the commercial and agricultural structures in the county are oriented toward this crop. Other cash returns for the residents lie mainly in cattle raising and oil production.

There are four towns in the county with 500 or more population; Shattuck, Gage, Fargo, and Arnett, the county seat. The population of the county as of the latest census is 5596, with most of that population dispersed into the outlying farmlands. Only Shattuck has a population that exceeds one thousand. Most of the county was settled between 1901 and 1906, with a large influx of immigrants of Russian-German ancestry.

The dominant architectural characteristic of the towns is simple, functional, one or two story buildings laid out in linear main-street configuration. The prairie environment generally dictates the necessity for keeping structures low and small, particularly before the advent of interior climate control. Most structures are built of stone or brick. The county has few recreational facilities as the dry flatlands do not promote much recreation. Hunting and fishing are popular and these sports also have contributed to cultural developments of the residents of the county.

Many of the bank buildings are similar in construction techniques and materials. They are mostly rectangular structures with entranceways on a cutaway corner. The buildings give the general architectural impression of either the Romanesque or Greek Revival style. Most of the buildings are constructed of brick and all are flat-roofed, one or two story structures. The buildings are generally the same size and the interiors had the same type fixtures, generally oak and marble. All the structures have pressed tin ceilings still in place and the original bank vaults are also in the buildings. Overall, the buildings maintain a similarity that express harshness and isolation resulting in basic, functional structures.

The survey was conducted by John Wensorski, a graduate masters student at Oklahoma State University concentrating on Historical Preservation. All of the county was surveyed and no subsurface archeological testing was conducted as the nomination is considered complete without such tests. Information from the Oklahoma State Banking Commission and the Woodward County Historical Museum was used to identify and assess properties. Numerous individual interviews and newspaper searches also provided informational data and materials for this nomination.

Statement of Significance (in one paragraph)

These buildings are historically significant because they are the remaining buildings used to house the first banking facilities instituted in Ellis County. These facilities were instrumental in the development of this area not only commercially but agriculturally. Between the years 1901 and 1924, seventeen banks were chartered or converted as evidenced by the Oklahoma State Banking Commission. These institutions were distributed between the four towns of Shattuck, Gage, Fargo, and Arnett, with three banks in Gage, two in both Arnett and Fargo, and Shattuck garnering the remaining ten. These banks provided regular banking services to both the town and the surrounding community and contributed greatly to the development and growth of the area by making loans for farm purchases and improvements, business loans for purchase and/or expansion, and a ready cash flow to induce new settlers and immigrants to remain in the county. Although some of the institutions failed during the troubled times of the twenties and thirties, most would survive to provide continued services to the community, often depending on the personal assets and honest of the stockholders to stay in business. Many of the banks provided services to the community that would be considered unorthodox today, such as, remaining open as late as there were customers to be served. During the depression, and "dust bowl" years of the thirties, those banks that remained solvent helped to stabilize the community economically through continuity of banking services.

Organized by early pioneers to Ellis County such as, J.J. Hamre, A.M. Benbrook, J.H.C. Stuart, J.L. Pryor, John A. Holt, and C.Q. Chandler of Kansas, many of the banks were started with capital investments as low as \$10,000 that sum often being the entire assets of the founder. Far-sighted businessmen who saw the need for banking facilities within the community would respond to a bank's closing by quickly organizing another bank. This attitude has resulted in the prosperity of the county with the result that the towns of Arnett, Shattuck and Gage all have modern facilities that have flourished over the years and are stable foundations for continuous community development.

Only one bank remains in its original building, all others still in operation having moved to newer, more modern facilities. All of the remaining bank buildings, save one, have continued to provide housing for various community businesses and social organizations and are all in use at this time. These buildings are being used commercially except for the Shattuck National building which is being used as the public library. The subdued Romanesque theme that is evident in most of these structures conveys the idea of solidity and stability desirable of new businesses looking for a place of residency and naturally attracted continuous use over the years.

All of the existing bank buildings in Ellis County have been included in this nomination with the exception of the facility that housed the Guarantee State Bank, which could not be properly identified. This facility existed within a row of commercial buildings and numerous attempts to determine exactly which buildings was used ended in failure. No physical evidence was found in any of the buildings that indicated a bank was housed therein, as the bank actually was being housed in a commercial structure not specifically built for it.

Overall, the group of buildings establishes a platform that provides specific information on the economic development of Ellis County and demonstrates that these facilities were instrumental in improving the economic base of this western Oklahoma county.

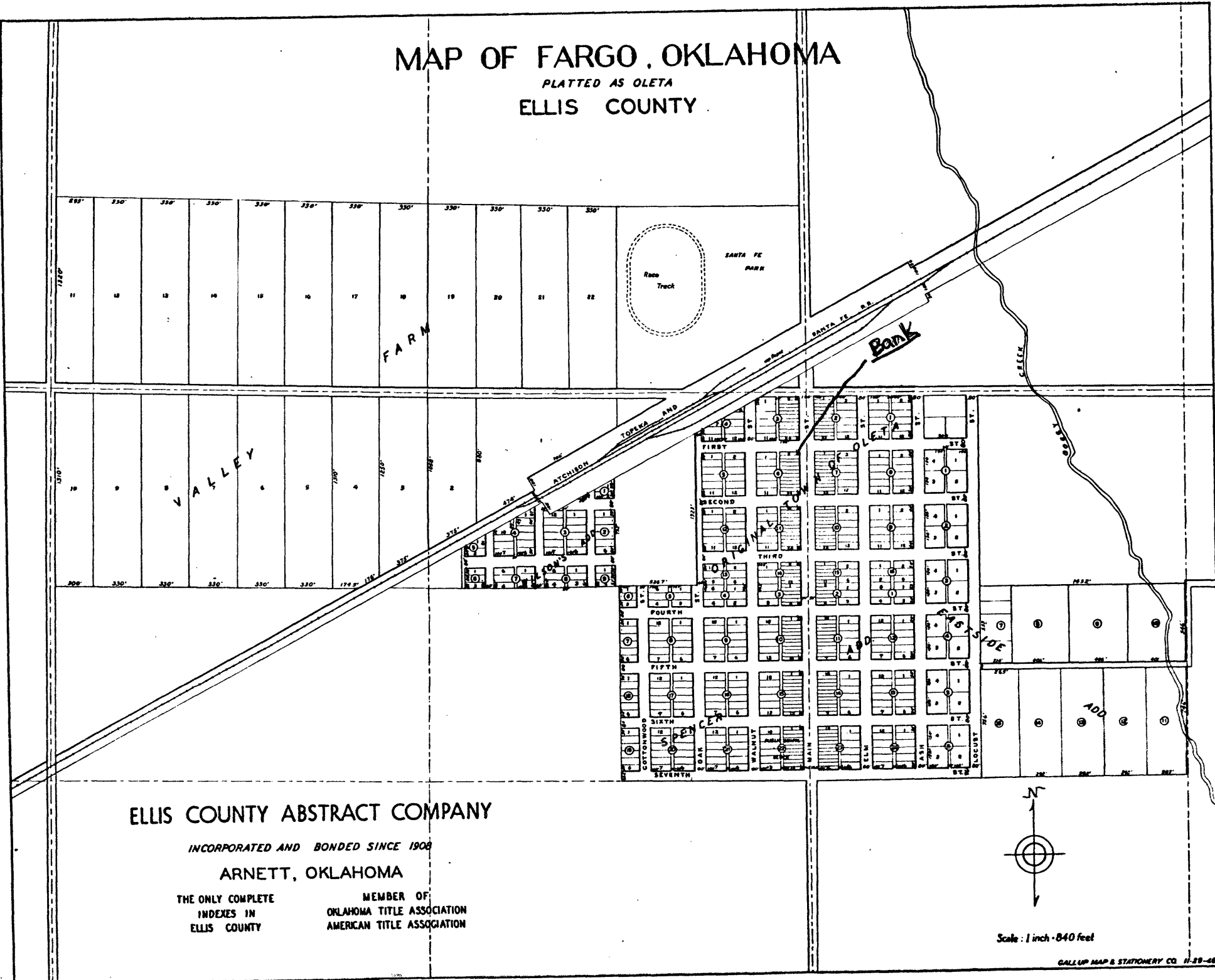

ELLIS COUNTY



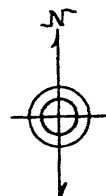
